

**COMMISSIONER MUNICIPAL CORPORATION, CHANDIGARH

Order

Whereas the notification has been issued by the Home Secretary, Govt. of India as per office order No.40-3/2020-D dated 24.3.2020 regarding measures to be taken for containment of COVID-19 epidemic in the country. An order under Section 144 Cr.PC and further clarifications have also been issued by the District Magistrate, Chandigarh.

And, whereas vide Chandigarh Administration Home Department's office order No.HH(2)-2020/4289 dated 25.03.2020 the undersigned has been given the overall responsibility for providing of essential services related to food, grocery items, fruits and vegetables, dairy and milk products etc.

And, whereas the District Magistrate, Chandigarh has further modified the relaxation order for public vide his order No.DM/MA/2020/8433 dated 22.4.2020 to visit for their daily needs of essential commodities from nearby shops of essential commodities from 10 AM to 2 PM.


And whereas through the aforesaid order, the timing of home delivery of essential commodities by the shopkeepers was left to be decided.

Therefore, the undersigned, hereby fix the timings for opening of shops strictly for home delivery of essential commodities by the shopkeepers and other online delivery agencies i.e. Zomato and Swiggy etc. as under:-

Essential Commodity	Timings
Grocery/kiryana, meat & fish, Fruit & Vegetable	9:00 AM to 9:00 PM
Milk & Eggs	5:00 AM to 9:00 PM

Note: The present order is applicable only for shopkeepers and other online agencies and not for general public.


