The undersigned in exercise of the powers conferred under Section 22 of the Disaster Management Act, 2005, in my capacity as Chairperson, State Executive Committee, State Disaster Management Authority is hereby order that all the activities including Boating will remain closed at Sukhna Lake except from 5.00 AM to 9.00 AM and from 6.00 PM to 8.00 PM from Monday to Saturday, during which morning / evening walkers/ visitors will be allowed with proper covid protocol. The police will ensure that the visitors / morning / evening walkers at lake follow the covid protocol strictly, failing which challans will be issued. However, Sukhna Lake will remain closed on every Sunday.

This order shall come into force with effect from **03.01.2022** and will be applicable until further orders.

Any breach of this order shall invite action under Section 51 to 60 of the Disaster Management Act, 2005 and Section 188 of the Indian Penal Code alongwith other applicable laws.


