
ORDER

Dated 13-01-2022

Further to order No.13180-HIII(5)-2022/2095, dated
06.01.2022, it is hereby ordered as under:-

- (1) The Hotels/Restaurants/café/coffee shops/eating places will be allowed to function upto 10.00 PM. However, kitchens of these premises will be allowed to remain open upto 11.00 PM and no home delivery is allowed after 12.00 midnight.
- (2) Persons with disabilities and pregnant women employees in government offices in Chandigarh shall be exempted from attending office but are required to work from home.
- (3) Public Transport including Bus, Taxi, Auto Rickshaw etc. will run only with their permitted seating capacity. In case of violations, strict action under appropriate law will be taken.

This order shall come into force with effect from 14.01.2022
and will be applicable until further orders.




